The development comprises four units, with three of the units let to the following:

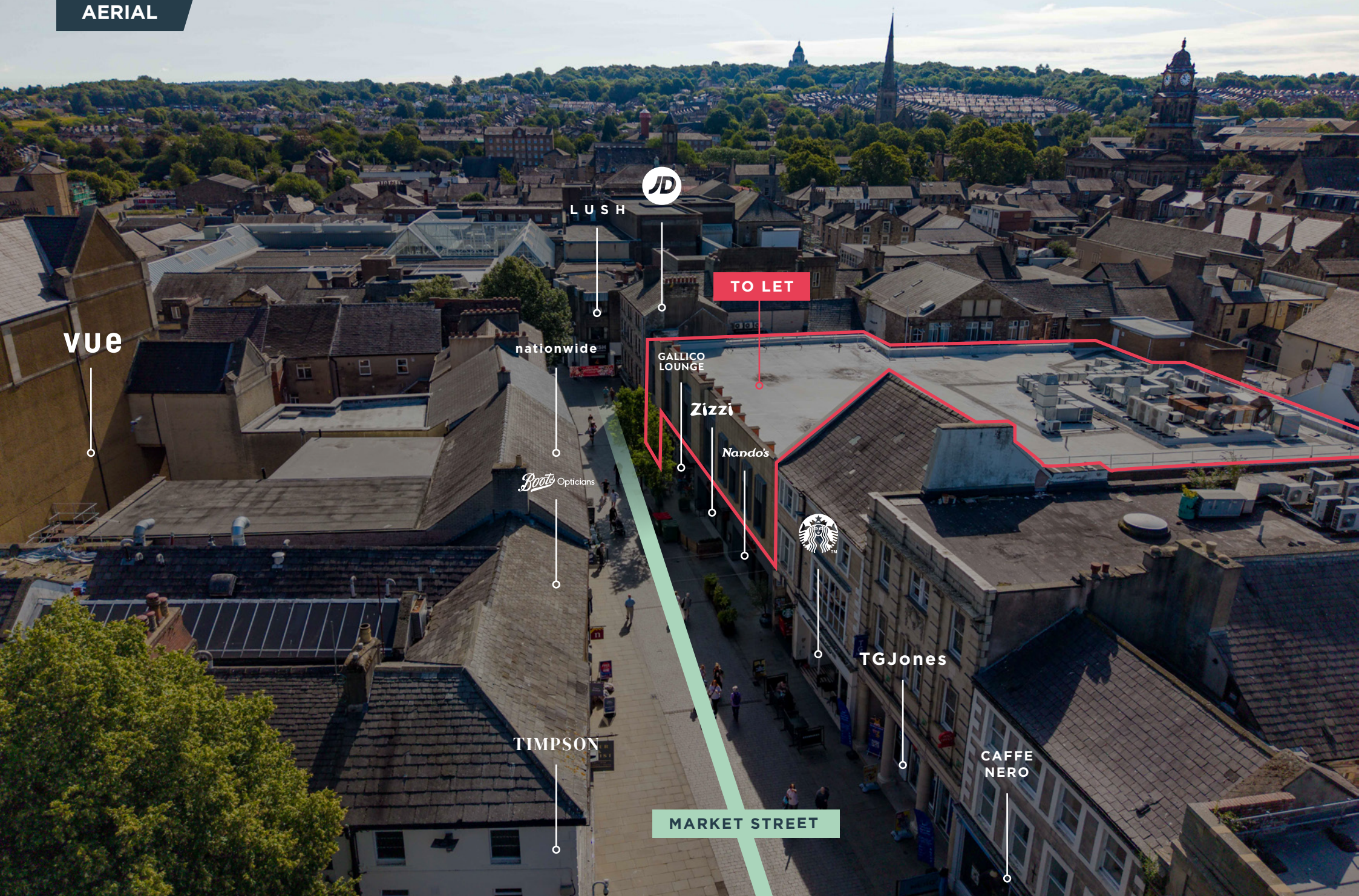

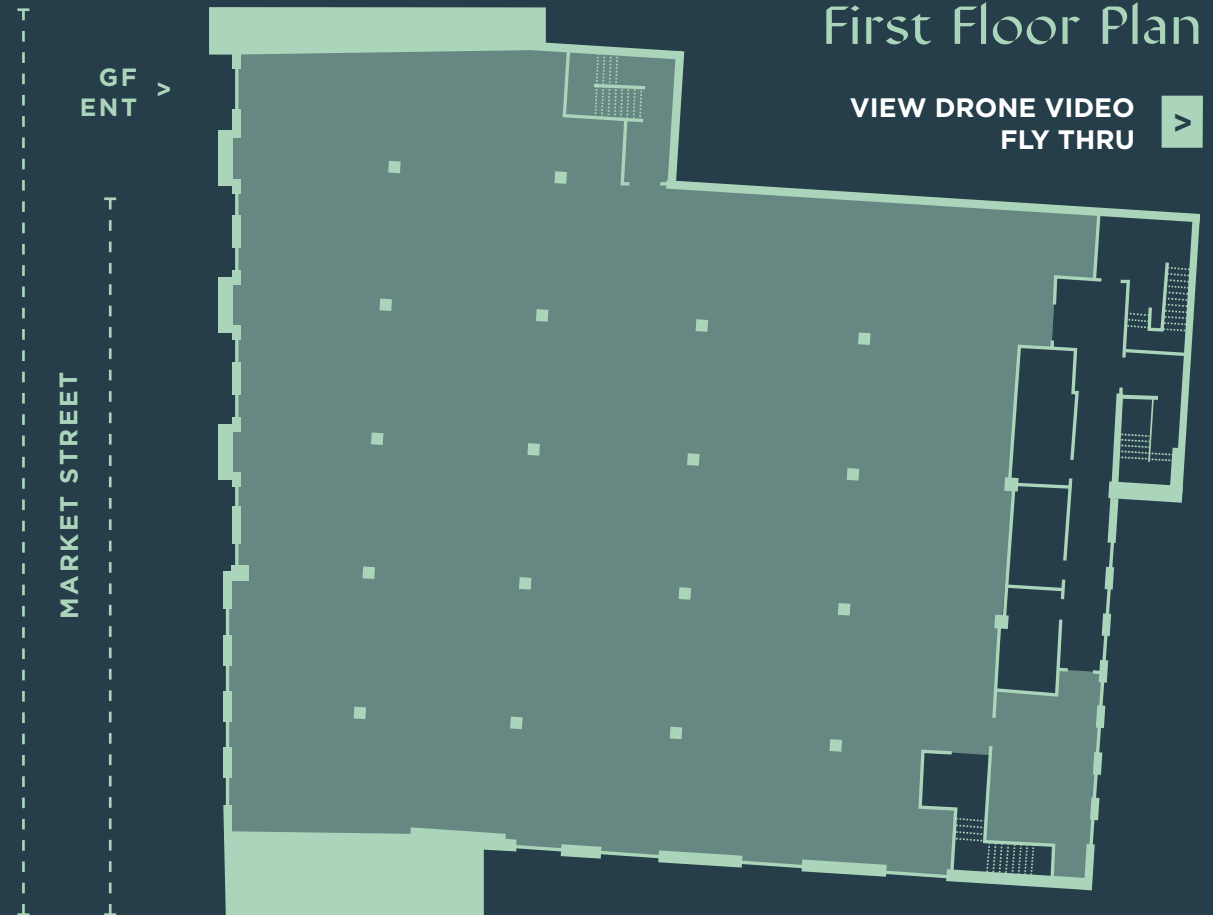
FLOOR PLAN
